

RESOLUTION NO. 4

A RESOLUTION OF THE TOWN COUNCIL OF UPTON, WESTON COUNTY,
WYOMING ADOPTING UTILITY RATE, DEPOSIT AND FEE AMOUNT
INCREASES FOR THE FISCAL YEAR 2018-2019

WHEREAS, the Town Council of Upton, Weston County, Wyoming has found it necessary to update rates, deposits and fees associated with enterprise funds; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming imposes fees to recoup the costs of all services resulting from all enterprise funds expenditures; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming is required to balance the budget and all enterprise funds must be self sustaining; and

NOW, THEREFORE BE IT RESOLVED by the Town Council of Upton, Weston County, Wyoming that rate, deposit and fee increases in the following particulars will become effective July 1, 2018:

1. The minimum charge for water service shall increase by approximately 5% or \$0.50 from \$14.50 to \$15.00 for all user types.
2. The minimum charge for water service shall increase by approximately 5% or \$1.00 from \$29.00 to \$30.00 for out-of-city-limits users.
3. The rate for each additional 1,000 gallons of water used over the initial 1,000 gallons included in the base rate shall increase approximately 5% or \$0.10 from \$2.90 to \$3.00 per thousand for all user types.
4. The rate for each additional 1,000 gallons of water used over the initial 1,000 gallons included in the base rate shall increase approximately 5% or \$0.20 from \$5.80 to \$6.00 for out-of-city-limits users.
5. The sewer service rate shall increase by approximately 5% or \$1.00 for all user types.
6. All garbage service rates shall increase by approximately 5% or \$1.50 per month per container class.
7. The deposit amount for a residential customer account shall be established at \$125.00 and shall be paid to the Town Clerk-Treasurer before services are connected.
8. The deposit amount for a commercial customer account shall be established at \$150.00 and shall be paid to the Town Clerk-Treasurer before services are connected.
9. The service fee for new connections shall be established at \$20.00 per occurrence and shall be paid to the Town Clerk-Treasurer before services are connected.
10. The service fee for all service disconnections, whether permanent or temporary, shall be established at \$20.00 per occurrence.
11. The monthly late fee for utility accounts not **paid in full** on the 25th of each month shall be established at \$5.00 per month.
12. The fees for service disconnection due to non-payment shall be established at \$20.00 for a penalty, \$20.00 for a service disconnection, and \$20.00 for a service re-connection for a total of \$60.00 in penalties and fees due for each disconnection occurrence.
