

ORDINANCE NO. 3, SERIES 2017

AN ORDINANCE ADOPTING THE STATE OF WYOMING LIQUOR LAWS AS ENFORCEABLE TOWN ORDINANCES FOR THE TOWN OF UPTON.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF UPTON, WESTON COUNTY, WYOMING

TITLE 12 ALCOHOLIC BEVERAGES

SECTION 1: INCORPORATION AND ADOPTION OF STATE LIQUOR LAWS.

The Town of Upton hereby adopts and incorporates into the ordinances of the Town of Upton Title 12 of the Wyoming Statutes governing alcoholic beverages except to the extent this ordinance is more stringent than Title 12. The Town reserves the right to adopt more stringent liquor laws in the future by enacting specific ordinances. Unless subsequent ordinances are enacted to the contrary, this ordinance will incorporate and adopt future amendments to Title 12 as lawfully enacted by the Wyoming Legislature.

SECTION 2: DEFINITIONS – for the purposes of this Ordinance, all definitions contained in Title 12 of the Wyoming Statutes shall be incorporated herein by reference.

SECTION 3: HOURS OF OPERATION.

The hours of operation for all liquor licensees in the town of Upton shall be as follows:

Monday—Sunday: Six a.m. to two a.m.

SECTION 4: MINORS AND ALCOHOLIC BEVERAGES.

- A. Except as otherwise provided pursuant to Wyoming Statute §12-6-101, no person under the age of twenty-one (21) years shall:
- i. Purchase or attempt to purchase any alcoholic liquor or malt beverage;
 - ii. Solicit another person to purchase alcoholic liquor or malt beverage;
 - iii. Possess any alcoholic liquor or malt beverage;
 - iv. Consume any ethyl alcohol;
 - v. Have measureable blood, breath or urine alcohol concentration in his body; or
 - vi. Enter or remain in an establishment that is primarily for off-premises sales of alcoholic liquor or malt beverages unless accompanied by a parent, spouse or legal guardian who is twenty-one (21) years of age or older.

SECTION 5: REPEAL

This ordinance hereby repeals sections 9.04.060 and 9.04.065 of the Upton Municipal

Code and any other previously enacted ordinances governing liquor laws adopted by the Town of Upton.

SECTION 6: ADOPTION OF THIS ORDINANCE BY EMERGENCY

This ordinance shall be adopted by emergency pursuant to the provisions of Wyoming Statute §15-1-115 and shall take effect immediately upon proclamation by the Mayor.
