RESOLUTION FOR VACATION OF THE ALLEY and PORTIONS OF WHITETAIL STREET IN BLOCK 40, SAWMILL ADDITION, TOWN OF UPTON, WYOMING

WHEREAS, Kyle Materi with Wyo Services, Inc. has requested the Town of Upton to vacate the alley in Block 40 and a portion of Whitetail Street between Sawmill Avenue and Laurel Avenue, Sawmill Addition, and

WHEREAS, the Town of Upton believes it may be in the best interest of the Town and its residents to vacate this alley and portion of the street as requested.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF UPTON, WYOMING:

1. The Town of Upton, Wyoming, shall publish notice to vacate for three consecutive weeks in the Weston County Gazette, Upton, Wyoming. This notice shall be substantially as follows:

To All It May Concern: A petition has been filed with the Upton Town Council requesting that it vacate a public street in the Town of Upton, Wyoming, as follows:

- a) The alley in Block 40, Sawmill Addition, Upton, Weston County, Wyoming between Laurel Avenue and Sawmill Avenue.
- b) That portion of Whitetail Street lying between and immediately adjacent to Block 40 on the south and Block 47 on the north, Sawmill Avenue to the east and Laurel Avenue to the west, Sawmill Addition, Upton, Weston County, Wyoming.

All objections to the vacation or claims for damages by reason of such vacation must be filed in writing with the Upton Town Clerk, P.O. Box 203, Upton, Wyoming, 82730, or at the Upton Town Hall, before noon on the 13th day of October, 2020. If not timely filed, this may be vacated without reference to such objections or claims for damages. The Town Council will consider this matter at its meeting on October 13, 2020, at 7:15 P.M.
