

ORDINANCE NO. 5 , SERIES 2023

AN ORDINANCE VACATING ALL OF HALF STREET IN THE NEIMAN ADDITION, TOWN OF UPTON, WYOMING

* * *

WHEREAS, a Resolution for the vacation of Half Street in the Neiman Addition, Upton, Wyoming was passed by the Upton Town Council on November 7, 2023; and

WHEREAS, public notice of the proposed vacation was published for three consecutive weeks in the Weston County Gazette in Upton, Wyoming, and

WHEREAS, no objections or claims for damages were timely filed or otherwise presented to the Upton Town Council at a public hearing on December 12, 2023, and

WHEREAS, it is in the best interests of the Town of Upton and the public that this alley be vacated,

THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF UPTON, WESTON COUNTY, WYOMING:

1. The following-described alley in the Town of Upton, Wyoming, is hereby vacated:

All of Half Street lying between and immediately adjacent to Blocks 15 on the north and Block 16 on the south, Neiman Addition, Upton, Weston County, Wyoming.

2. The Town of Upton, Wyoming, hereby reserves a perpetual easement upon the vacated street and alley for the installation and maintenance of all utilities furnished by the town of Upton now or in the future, including but not limited to drainage, sewer and water. The Town of Upton, Wyoming, further reserves a perpetual easement upon the vacated street and alley for the use of its present and future franchisees to install and maintain utilities, including but not limited to electricity, telephone, cable television, gas, internet access and fiber optics.

3. The vacated street shall pass to and vest in the present adjacent landowner or landowners according to the portions contributed by the adjacent landowner or landowners or their predecessors in interest.

4. This vacation shall be effective immediately upon passage and publication of this ordinance.
